Lightning Source is pleased to offer an electronic payment option of your monthly Publisher Compensation earnings – directly to your bank account.

1. Payment is electronically transmitted to your designated banking institution – securely.
2. Delays are eliminated. Electronic payments save you time. Depending on the institution, earnings are available immediately upon deposit. No deposit slips, no waiting in line and no trips to the bank.
3. A printable remittance advice is sent directly to your email inbox for your records.
4. The confirmation of payment is sent as a PDF file and can easily be printed or viewed on your PC (sample attached) with the same information and in the same format as the current paper check and remittance advice currently sent to our customers.

If you do not have Adobe Acrobat Reader on your PC, you can download a complimentary copy of Acrobat Reader at www.adobe.com/products/acrobat/readstep2.html. Once installed, your email will always be able to open the PDF confirmation by simply double-clicking the file.

HOW DO I START RECEIVING PUBLISHER COMPENSATION PAYMENTS ELECTRONICALLY FROM LIGHTNING SOURCE?

It's simple. Complete the form on the next page and return it to Lightning Source by mail or by fax, using the information provided.

When forms are received, we process your information, record your bank/depository account information and add your email address to our system. You will then start to get your monthly Publisher Compensation payment and remittance advice electronically.
